We discussed right and wrong and the appearance of doing good in our lives. The lesson of the degree focused on the judgement of one's life in the Egyptian tradition of weighing ones heart. For some reason this reminded me of a custom which is rising in popularity or perhaps just discussion called Malicious Compliance. This involves a form of rebellion against companies primarily who may change a policy that may have been beneficial to the employee. The employee rebels by following the rules to the letter which due to a lack of forethought creates issues

for the company, costing them money or productivity that they had taken for granted. The employee is not breaking any rules and therefore cannot really be held accountable.

My thought when it relates to this degree as well as Masonry as a whole, is that following rules to the letter is not really the most productive or reasonable thing to do for the Order. This can be just doing the bare minimum that is required per our bylaws and constitutions. While some may consider this a good thing, I do not believe that it promotes success. I have even heard this stated at a recent class from those in elevated positions. We can lose the spirit of the rules when focusing on only complying to the letter. We must look beyond the letter of the rules to push the limits of what we CAN do to the benefit of all who share this journey as well as those who come behind us. 
